6. STUDENT AND STAFF RECOGNITION/ANNOUNCEMENTS FROM THE SUPERINTENDENT OF SCHOOLS

Presentations: 6.01 Accomplishments of Staff and Students

6.01.1 Mr. Mark Dantuono, District Director for Health, Physical Education & Athletics, introduced State Champion Swimmer Chloe Stepanek

President Rapiejko and Superintendent Banzer congratulated Chloe on her accomplishments and presented her with a commendation from the Board.

6.01.2 Ms. Robin Rann, District Chairperson for Mathematics, introduced Nicholas Holfester, Mathematics Department Student of the Month.

Ms. Rann stated that Nick is mature, hard-working, and intrinsically motivated. He has successfully transferred his academic knowledge and interest in problem solving to real work design. Nick's IB Technology Design exam yielded his creation of a functionary prototype of a running shoe with easily retractable spikes, earning him the nearly impossible score of 7 on his IB research exam. Nick earned a Gold Medal at the Long Island Math Fair and was one of only three students to earn a perfect score on the SAT Subject Test in Physics. He is an active participant in National Honor Society, Technology and Engineering Education Honor Society, Tri-M Honor Society, and Foreign Language Honor Society. Nick runs cross country, is team captain, participates in SHARE and Relay for Life. He also participates in All-State Band, NYSCAME-All County, SCMEA-All County, Symphonic Band and Orchestra, Jazz Band, Pit Orchestra, and Marching Band. Nick is a camp counselor and a participant in a local youth group as well as being a Boy Scout. He was named the Rensselaer Medalist for his outstanding performance in the STEM disciplines and for his fascination with understanding how and why things work the way they do.

Ms. Rann noted that Nick's accomplishments are many but it is his kindness and compassion that truly set him apart. He is truly a thinker, an artist, a problem solver who competes only with his personal best, as well as being empathetic, giving, and humble.

President Rapiejko and Superintendent Banzer congratulated Nick on his fine accomplishments and presented him with a commendation from the Board.

6.01.3 Mr. David Storch, District Chairperson for Science and Technology, introduced Julianne Starzee, Science Department Student of the Month.

Mr. Storch stated that Julianne is an International Baccalaureate Diploma Candidate, a National Merit Semifinalist, has taken honors scientific investigation courses in Living Environment, Chemistry, and Physics, and is currently challenging IB Physics. She has established herself as a serious science and research student demonstrating a natural inquisitiveness, a determination to comprehend complex concepts, and superb laboratory and experimental skills. She has been conducting scientific research at Northport High School for the past three years. Julianne's research interests can best be described as eclectic; she has studied fungal enzymes, oyster shell growth, and rat behavior. Mr. Storch noted that Julianne attended the Long Island Youth Ocean Conservation Summit last November and received a minigrant for her oyster research project. She conducted research at Stony Brook University in the Department of Neurobiology and Behavior. Julianne presented her research findings at the Long Island Science Congress, a regional science research competition and in February she will present the results of her neuroscience research project at the Long Island Science and Engineering Fair. Julianne is a member of

the National Honor Society, Science Olympiad team, Mathletes, and newspaper club. She is also a member of the school cross country team, softball team, plays the flute in Symphonic Winds, earned All-State honors from NYSSMA, and sings in the Tour Choir. Outside of school, Julianne works as a referee for soccer games and participates in Girl Scouts.

Mr. Storch stated that Julianne is a self-starter, self-reliant, attempts to solve problems before seeking help and knows her strengths and limitations.

President Rapiejko and Superintendent Banzer congratulated Julianne on her fine accomplishments and presented her with a commendation from the Board.

6.01.4 Mr. David Storch, District Chairperson for Science and Technology, introduced Jason Aiello, Technology Department Student of the Month.

Mr. Storch stated that Jason is a studious and self-motivated young man who possesses the skills and knowledge to design a better tomorrow using technology and engineering. He has taken five different technology courses achieving mastery in each one. His coursework includes three PLTW Engineering courses, IB Design Technology, and robotics. Jason is challenging some of the most rigorous coursework including AP Calculus BC and IB Physics HL. His hard work and persistence in all his STEM courses exemplify his strong work ethic and desire to succeed as a future engineer. Mr. Storch noted that Jason is an exceptional individual whom has stretched well beyond the boundaries of the classroom to accomplish the highest possible goals including the demanding and prestigious International Baccalaureate Diploma. His willingness to experiment with new ideas and practices and his innovation and dedications play a very significant role in the ongoing development and growth of the program at Northport High School. Jason's extracurricular participation and leadership are quite impressive. His activities include being a starting member of both the varsity lacrosse team as well as the football team where is also captain. Jason is wellliked and respected by his peers, genuinely concerned for his fellow students, demonstrating a level of integrity, poise, and sensitivity that is the embodiments of a gentleman, an athlete, and a scholar. He is currently working on his Eagle Scout project designing and building a wheelchair accessible stone patio at the end of life care unit at the VA Hospital. Jason regularly volunteers for youth clinics and camps in the community, and is highly involved in the Project Vets Club as vice president and coordinator for the "LAX for Vets" fundraiser.

Mr. Storch stated that Jason is a future engineer, a scholar-athlete, and a humanitarian who is a strong candidate for admission to West Point next fall.

President Rapiejko and Superintendent Banzer congratulated Jason on his fine accomplishments and presented him with a commendation from the Board.

Information: 6.02 Indoor Air Quality Update

Superintendent Banzer stated that the District owns 20 buses: 12 full size diesel buses, 2 diesel vans, 2 gas vans, and 3 full size propane buses. Typical fueling occurs before school from 6:30 – 7:30 am and after school after 3:30 p.m., 2-3 times per week depending on the number of routes. During the typical morning bus run they depart at 6:50 a.m. and return at 9:30 a.m. In the afternoon they depart at 2:15 p.m. and return at 4:30 p.m. Mr. Banzer stated that the diesel comes treated from the supplier and that the monitoring of idling buses is done through GPS. Mr. Banzer noted that the District does have an anti-idling policy.

Mr. Banzer stated that at the end of October he presented on an indoor air quality program. The program has been implemented and has been continually refined using Tools for Schools. In October Phase I and II were completed. Phase III training was completed on December 4th and the District is now working on establishing an IAQ team. The implementation of a rigorous training program for all custodial, maintenance and ground staff emphasizing best practices is underway. Mr. Banzer stated that he is

gathering information on reorganizing the leadership structure within the department to provide more support and oversight and will make a recommendation to the Board in January.

Mr. Ed McGuire from J.C. Broderick stated that CO monitoring was performed at Northport Middle School. The testing began on November 28th starting interviewing district representatives, walking through the building and identifying primary sources, i.e., the kitchen, outside boiler plant and the space in between the bus depot. The testing was performed using portable data loggers over 48 hours, with CO levels taken at an interval of every five minutes. Mr. McGuire stated that 406 hours of data was collected at 4,872 data points. Across G, H and K wings no CO was detected in any areas. During bus activity throughout the student occupied areas there was no CO detection. In the kitchen there was some detectible levels of CO up to 5.3 parts/million. The CO levels fall into two categories, the OSHA permissible level is 50 parts/million and the EPAs national ambient air quality standard which is 9 parts/million. The testing performed between 8:00 a.m. and 1:30 p.m. showed an average of 1.2 parts/million. Mr. McGuire stated that they also monitored levels within the cafeteria which showed no detectible levels. The testing in the kitchen was performed when the exhaust fans were not in use. Testing was then done when the fans were in use and the CO levels were almost nonexistent. A recommendation was made to train the staff on the use of ventilation.

There was a discussion regarding OSHA and EPA standards, New York State standards for air quality, testing performed when buses were active, limits of detection of testing equipment, placement of testing equipment, and training of kitchen staff.

In response to a question regarding concerns about elevated levels of CO, Mr. McGuire stated that based on the test data it is not from the bus depot at Northport Middle School.

9. SPECIAL REPORTS

Presentations: 9.01 Strategic Plan Introduction

Superintendent Banzer and Dr. Dana Boshnack, Assistant Superintendent for Teaching and Learning, presented on the District's Strategic Plan. The core values and beliefs were established with attention to ten priority areas. The immediate priority areas are to: Create and implement a comprehensive, K-12 Social-Emotional Learning Plan; Align K-12 curricula with explicit goals and measurable outcomes that include opportunities for enrichment and remediation; Establish a system to deliver focused and sustained professional development targeting the needs identified in this plan; Implement a strategic planning process at the district and building level. Three district-wide committees including representation from all nine buildings were established: Social Emotional Learning, Professional Development and Curriculum Council.

Presentations: 9.02 Strategic Plan Update: Science, Technology and Mathematics Departments - Ms. Robin Rann, District Chairperson of Mathematics, and Mr. David Storch, District Chairperson of Science and Technology presenting

Ms. Rann and Mr. Storch reviewed the Strategic Plan with regards to Mathematics, Science and Technology - students are our first priority. The strategic plan for curriculum and assessment is to align K-12 curricula with explicit goals and measurable outcomes that include opportunities for enrichment and remediation.

Ms. Rann reviewed the elementary and secondary mathematics curriculum and assessment since 2012-2013 and since 2016-2017, and the curriculum and assessments next generation, next steps, and Understanding by Design, Backward Planning: Begin with the End in Mind. Ms. Rann reviewed the three stages of Understanding by Design, Stage 1: Identify Desired Results, Stage 2: Determine Acceptable Evidence; Stage 3: Plan learning experiences and instruction.

Mr. Storch stated that the goal of science education through three-dimensional teaching and learning is to design lessons that move students through the crosscutting concepts while teaching disciplinary core ideas and engage students in appropriate Science and Engineering practices to help ensure that students are learning Science by doing Science. Students must be engaged in the nexus of three dimensions. Science education is not the abstract recall of facts, instead students must demonstrate proficiency in science by engaging in scientific practices. Mr. Storch reviewed the 5E stages of science instruction, and the elementary and middle school science curriculum development

Mr. Storch reviewed the 2016-2017 and 2017-2018 professional development workshops and training, and the ongoing and upcoming turnkey professional development.

Ms. Rann reviewed the evolving math instruction for student learning including critical thinking, collaboration, productive struggle, metacognition, cognitive demand and clear learning targets. Ms. Rann

reviewed the 2016-2017 and 2017-2018 professional workshops and training, and the ongoing and upcoming professional and turnkey development.

There was a discussion regarding student test data, course offerings, next generation science standards and performance expectations.

The Board thanks Ms. Rann and Mr. Storch for their very informative report.

6. STUDENT AND STAFF RECOGNITION/ANNOUNCEMENTS FROM THE SUPERINTENDENT OF SCHOOLS

Presentations: 6.01 Accomplishments of Staff and Students

6.01.1 Mr. Mark Dantuono, District Director for Health, Physical Education & Athletics, introduced State Champion Swimmer Chloe Stepanek

President Rapiejko and Superintendent Banzer congratulated Chloe on her accomplishments and presented her with a commendation from the Board.

6.01.2 Ms. Robin Rann, District Chairperson for Mathematics, introduced Nicholas Holfester, Mathematics Department Student of the Month.

Ms. Rann stated that Nick is mature, hard-working, and intrinsically motivated. He has successfully transferred his academic knowledge and interest in problem solving to real work design. Nick's IB Technology Design exam yielded his creation of a functionary prototype of a running shoe with easily retractable spikes, earning him the nearly impossible score of 7 on his IB research exam. Nick earned a Gold Medal at the Long Island Math Fair and was one of only three students to earn a perfect score on the SAT Subject Test in Physics. He is an active participant in National Honor Society, Technology and Engineering Education Honor Society, Tri-M Honor Society, and Foreign Language Honor Society. Nick runs cross country, is team captain, participates in SHARE and Relay for Life. He also participates in All-State Band, NYSCAME-All County, SCMEA-All County, Symphonic Band and Orchestra, Jazz Band, Pit Orchestra, and Marching Band. Nick is a camp counselor and a participant in a local youth group as well as being a Boy Scout. He was named the Rensselaer Medalist for his outstanding performance in the STEM disciplines and for his fascination with understanding how and why things work the way they do.

Ms. Rann noted that Nick's accomplishments are many but it is his kindness and compassion that truly set him apart. He is truly a thinker, an artist, a problem solver who competes only with his personal best, as well as being empathetic, giving, and humble.

President Rapiejko and Superintendent Banzer congratulated Nick on his fine accomplishments and presented him with a commendation from the Board.

6.01.3 Mr. David Storch, District Chairperson for Science and Technology, introduced Julianne Starzee, Science Department Student of the Month.

Mr. Storch stated that Julianne is an International Baccalaureate Diploma Candidate, a National Merit Semifinalist, has taken honors scientific investigation courses in Living Environment, Chemistry, and Physics, and is currently challenging IB Physics. She has established herself as a serious science and research student demonstrating a natural inquisitiveness, a determination to comprehend complex concepts, and superb laboratory and experimental skills. She has been conducting scientific research at Northport High School for the past three years. Julianne's research interests can best be described as eclectic; she has studied fungal enzymes, oyster shell growth, and rat behavior. Mr. Storch noted that Julianne attended the Long Island Youth Ocean Conservation Summit last November and received a minigrant for her oyster research project. She conducted research at Stony Brook University in the Department of Neurobiology and Behavior. Julianne presented her research findings at the Long Island Science Congress, a regional science research competition and in February she will present the results of her neuroscience research project at the Long Island Science and Engineering Fair. Julianne is a member of

the National Honor Society, Science Olympiad team, Mathletes, and newspaper club. She is also a member of the school cross country team, softball team, plays the flute in Symphonic Winds, earned All-State honors from NYSSMA, and sings in the Tour Choir. Outside of school, Julianne works as a referee for soccer games and participates in Girl Scouts.

Mr. Storch stated that Julianne is a self-starter, self-reliant, attempts to solve problems before seeking help and knows her strengths and limitations.

President Rapiejko and Superintendent Banzer congratulated Julianne on her fine accomplishments and presented her with a commendation from the Board.

6.01.4 Mr. David Storch, District Chairperson for Science and Technology, introduced Jason Aiello, Technology Department Student of the Month.

Mr. Storch stated that Jason is a studious and self-motivated young man who possesses the skills and knowledge to design a better tomorrow using technology and engineering. He has taken five different technology courses achieving mastery in each one. His coursework includes three PLTW Engineering courses, IB Design Technology, and robotics. Jason is challenging some of the most rigorous coursework including AP Calculus BC and IB Physics HL. His hard work and persistence in all his STEM courses exemplify his strong work ethic and desire to succeed as a future engineer. Mr. Storch noted that Jason is an exceptional individual whom has stretched well beyond the boundaries of the classroom to accomplish the highest possible goals including the demanding and prestigious International Baccalaureate Diploma. His willingness to experiment with new ideas and practices and his innovation and dedications play a very significant role in the ongoing development and growth of the program at Northport High School. Jason's extracurricular participation and leadership are quite impressive. His activities include being a starting member of both the varsity lacrosse team as well as the football team where is also captain. Jason is wellliked and respected by his peers, genuinely concerned for his fellow students, demonstrating a level of integrity, poise, and sensitivity that is the embodiments of a gentleman, an athlete, and a scholar. He is currently working on his Eagle Scout project designing and building a wheelchair accessible stone patio at the end of life care unit at the VA Hospital. Jason regularly volunteers for youth clinics and camps in the community, and is highly involved in the Project Vets Club as vice president and coordinator for the "LAX for Vets" fundraiser.

Mr. Storch stated that Jason is a future engineer, a scholar-athlete, and a humanitarian who is a strong candidate for admission to West Point next fall.

President Rapiejko and Superintendent Banzer congratulated Jason on his fine accomplishments and presented him with a commendation from the Board.

Information: 6.02 Indoor Air Quality Update

Superintendent Banzer stated that the District owns 20 buses: 12 full size diesel buses, 2 diesel vans, 2 gas vans, and 3 full size propane buses. Typical fueling occurs before school from 6:30 – 7:30 am and after school after 3:30 p.m., 2-3 times per week depending on the number of routes. During the typical morning bus run they depart at 6:50 a.m. and return at 9:30 a.m. In the afternoon they depart at 2:15 p.m. and return at 4:30 p.m. Mr. Banzer stated that the diesel comes treated from the supplier and that the monitoring of idling buses is done through GPS. Mr. Banzer noted that the District does have an anti-idling policy.

Mr. Banzer stated that at the end of October he presented on an indoor air quality program. The program has been implemented and has been continually refined using Tools for Schools. In October Phase I and II were completed. Phase III training was completed on December 4th and the District is now working on establishing an IAQ team. The implementation of a rigorous training program for all custodial, maintenance and ground staff emphasizing best practices is underway. Mr. Banzer stated that he is

gathering information on reorganizing the leadership structure within the department to provide more support and oversight and will make a recommendation to the Board in January.

Mr. Ed McGuire from J.C. Broderick stated that CO monitoring was performed at Northport Middle School. The testing began on November 28th starting interviewing district representatives, walking through the building and identifying primary sources, i.e., the kitchen, outside boiler plant and the space in between the bus depot. The testing was performed using portable data loggers over 48 hours, with CO levels taken at an interval of every five minutes. Mr. McGuire stated that 406 hours of data was collected at 4,872 data points. Across G, H and K wings no CO was detected in any areas. During bus activity throughout the student occupied areas there was no CO detection. In the kitchen there was some detectible levels of CO up to 5.3 parts/million. The CO levels fall into two categories, the OSHA permissible level is 50 parts/million and the EPAs national ambient air quality standard which is 9 parts/million. The testing performed between 8:00 a.m. and 1:30 p.m. showed an average of 1.2 parts/million. Mr. McGuire stated that they also monitored levels within the cafeteria which showed no detectible levels. The testing in the kitchen was performed when the exhaust fans were not in use. Testing was then done when the fans were in use and the CO levels were almost nonexistent. A recommendation was made to train the staff on the use of ventilation.

There was a discussion regarding OSHA and EPA standards, New York State standards for air quality, testing performed when buses were active, limits of detection of testing equipment, placement of testing equipment, and training of kitchen staff.

In response to a question regarding concerns about elevated levels of CO, Mr. McGuire stated that based on the test data it is not from the bus depot at Northport Middle School.

Superintendent Banzer and Dr. Dana Boshnack, Assistant Superintendent for Teaching and Learning, presented on the District's Strategic Plan. The core values and beliefs were established with attention to ten priority areas. The immediate priority areas are to: Create and implement a comprehensive, K-12 Social-Emotional Learning Plan; Align K-12 curricula with explicit goals and measurable outcomes that include opportunities for enrichment and remediation; Establish a system to deliver focused and sustained professional development targeting the needs identified in this plan; Implement a strategic planning process at the district and building level. Three district-wide committees including representation from all nine buildings were established: Social Emotional Learning, Professional Development and Curriculum Council.

Presentations: 9.02 Strategic Plan Update: Science, Technology and Mathematics Departments - Ms. Robin Rann, District Chairperson of Mathematics, and Mr. David Storch, District Chairperson of Science and Technology presenting

Ms. Rann and Mr. Storch reviewed the Strategic Plan with regards to Mathematics, Science and Technology - students are our first priority. The strategic plan for curriculum and assessment is to align K-12 curricula with explicit goals and measurable outcomes that include opportunities for enrichment and remediation.

Ms. Rann reviewed the elementary and secondary mathematics curriculum and assessment since 2012-2013 and since 2016-2017, and the curriculum and assessments next generation, next steps, and Understanding by Design, Backward Planning: Begin with the End in Mind. Ms. Rann reviewed the three stages of Understanding by Design, Stage 1: Identify Desired Results, Stage 2: Determine Acceptable Evidence; Stage 3: Plan learning experiences and instruction.

Mr. Storch stated that the goal of science education through three-dimensional teaching and learning is to design lessons that move students through the crosscutting concepts while teaching disciplinary core ideas and engage students in appropriate Science and Engineering practices to help ensure that students are learning Science by doing Science. Students must be engaged in the nexus of three dimensions. Science education is not the abstract recall of facts, instead students must demonstrate proficiency in science by engaging in scientific practices. Mr. Storch reviewed the 5E stages of science instruction, and the elementary and middle school science curriculum development

Mr. Storch reviewed the 2016-2017 and 2017-2018 professional development workshops and training, and the ongoing and upcoming turnkey professional development.

Ms. Rann reviewed the evolving math instruction for student learning including critical thinking, collaboration, productive struggle, metacognition, cognitive demand and clear learning targets. Ms. Rann

reviewed the 2016-2017 and 2017-2018 professional workshops and training, and the ongoing and upcoming professional and turnkey development.

There was a discussion regarding student test data, course offerings, next generation science standards and performance expectations.

The Board thanks Ms. Rann and Mr. Storch for their very informative report.
