
Northport High School student Amaya Nieves, updated the Board on the current events happening at the high school.

# **Action Plan: Student Achievement**

Increase the percentage of students scoring an overall placement of "early on grade level" or "mid or above grade level" in both math and reading from the fall administration to the spring administration of the iReady diagnostic assessment.

#### iReady Training, Implementation and Response:

- Continue training grade 5-6 teachers on resources and tools to utilize through both the diagnostic and to support ongoing learning
- 7-8 teachers will be receiving second round of training in advance of the Spring assessment
- Teachers utilize iReady data, in addition to other assessment measures, to explore differentiated instructional approaches:
  - o Determine which students require additional services
  - o How to group students based on specific skill deficits
  - o Identify resources for specific lessons
- Administrators also attended two training sessions
- Collaboratively designed quarterly benchmark assessments, using Regents & iReady data
- Use iReady during common planning time and LST to identify specific AIS students and to initiate intervention strategies
  - Simultaneously, identify students who are currently in AIS but whose diagnostic testing results warrant revisiting their placements



- 1,103 students participated in survey (approximately 82%)
- 82 students were identified as being "at risk"; every student has been addressed based on their individual needs (approximately 7% of all four grade levels)
- Panorama results are now incorporated into our MTSS process and are used to identify students who may need support in specific areas



# **Action Plan: SEL**

Increase students' sense of belonging by gathering and incorporating student, staff, and parent input to drive inclusive SEL program initiatives with a focus on building relationships, routines, and resiliency for all.

#### Provide opportunities to build relationships and establish a sense of belonging in our school:

#### Ongoing:

- Offer professional development opportunities for staff on Responsive Classroom and Restorative Practice
- Analyze SEL feedback per Panorama surveys and identify students of concern to discuss with mental health staff.
- Developed and implemented SEL calendar for building-wide and grade-level events to support a sense of belonging.
- Teachers, mental health staff, and parents collaborate to review SEL needs of students on each team, and to create action plans to support them.
- Mental health staff and/or teachers are doing pre/post activities in classrooms to support yearlong immersion in the topics described above.
- Devote faculty meeting time to discussions about SEL/belonging practices.

#### So far this year:

- o Presented "Ryan's Story" to grades 6-8 in assemblies and to parents during a parent night.
- David Levine's presentation to 5-6 students regarding school of belonging and taking the high road.

#### ParentSquare Data:

- Total Middle School posts (August 2022-Present): 1,208 posts
- More than half of parents have downloaded the ParentSquare app
- Over 4,200 direct message threads (Parents communicating directly with teachers or staff)
  - o Over 16,000 individual messages
- Approximately 35% of parents have interacted with posts on ParentSquare ("appreciated", commented, etc.")
- 6% of ENMS parents and 4% of NMS parents are receiving communications in their home language, including Spanish, Czech, Greek, Russian, Urdu and more.
